

Con Edison Announces Public Offering of Common Shares

NEW YORK, NY, May 10, 2007 (MARKET WIRE via COMTEX News Network) -- Consolidated Edison, Inc. (Con Edison) (NYSE: ED) announced today it has agreed to issue 11,000,000 of its common shares, generating gross proceeds of approximately \$560 million. These common shares are being offered by J.P. Morgan Securities Inc. under Con Edison's effective shelf registration statement filed with the Securities and Exchange Commission. The common shares are expected to be issued on May 16, 2007, subject to customary closing conditions.

Con Edison expects to invest the net proceeds from the sale of the common shares in its regulated utility subsidiaries, Con Edison of New York and Orange and Rockland Utilities, for funding of their construction expenditures and for other general corporate purposes.

This press release shall not constitute an offer to sell or the solicitation of an offer to buy these securities, nor shall there be any sale of these securities, in any jurisdiction in which such offer, solicitation or sale would be unlawful prior to registration or qualification under the securities laws of any such jurisdiction. The offering of these securities may be made only by means of the prospectus and related prospectus supplement relating to the offering.
