- The Performance Units, granted in 2020, will vest on 12/31/22 and will be settled in 2023 when they are determined and awarded by the Management Development and Compensation Committee of the Company's Board of Directors (the "MD&C Committee").
- The number of shares (or cash equivalents) will be adjusted based on certain performance criteria, including criteria other than the market price, as specified under the Company LTIP.
- Not applicable.
- The Performance Units, granted in 2021, will vest on 12/31/23 and will be settled in 2024 when they are determined and awarded by the MD&C Committee.
- The Performance Units, granted in 2022, will vest on 12/31/24 and will be settled in 2025 when they are determined and awarded by the MD&C Committee.
- Each Time-Based Restricted Stock Unit represents a contingent right to receive one share of Company common stock.
- The Time-Based Restricted Stock Units, granted in 2022 under the LTIP, will vest 100% on 12/31/24.
